### Personal Data

Iyengar Yoga Luxembourg collects and maintains personal data of the students that are taking yoga classes with us or asking to subscribe to our newsletter. (the "Students"), in order to keep a file of its members, for the exercising of payment orders, and for the administration.

Iyengar Yoga Luxembourg shall be careful while collecting these data and will always comply with the GDPR.

Iyengar Yoga Luxembourg will also use the personal data as mentioned above to keep the Students informed about activities, and possible changes in, e.g., the class schedule.

We use WIX as our marketing automation platform and website provider, by sending us personal data student acknowledge that the information they provide will be transferred to WIX for processing in accordance with their Privacy Policy and Terms.

Without prior written consent, Iyengar Yoga Luxembourg will never transfer any personal data of the Students to a third party. However, we may share information with governmental agencies or other companies assisting us in fraud prevention or investigation. We may do so when: (1) permitted or required by law; or, (2) trying to protect against or prevent actual or potential fraud or unauthorized transactions; or, (3) investigating fraud which has already taken place. The information is not provided to these companies for marketing purposes.

### Cookie/Tracking Technology

[iyengaryoga.lu](http://iyengaryoga.lu) may use cookie and tracking technology depending on the features offered. Cookie and tracking technology are useful for gathering information such as browser type and operating system, tracking the number of visitors to the website, and understanding how visitors use the website.
